

Hello, League of Women Voters of Umpqua Valley Members!

I hope you are all safe, healthy, and avoiding crowds during the COVID-19 Delta variant outbreak. This outbreak is the reason our monthly meetings will continue to be conducted through our Zoom account until further notice. We were hoping we could meet in-person soon, but here we are again.

Redistricting in Oregon

There's a lot going on right this minute regarding redistricting. As you know, the decadal census has been completed and, thus, the re-writing of congressional district boundaries begins. Redistricting is happening all over the nation.

Here in Oregon, members of the public were invited to participate during one of the virtual hearings to provide feedback on the draft maps created by the committees. Congressional District #4 (some portions of Douglas County are also in District #2) hearings were held on Sept. 8 & 10. PDF versions of the maps are online. To view proposed maps and for other information, visit https://www.oregonlegislature.gov/redistricting/. Map submissions are now closed.

If you'd like to share your comments on the <u>OLIS</u> maps, please email them to <u>Oregon.Redistricting@Oregonlegislature.gov</u>. Be sure to include the name of the map(s) you are referencing. Received comments may posted on OLIS for a future hearing.

Here is a link to the <u>maps and article</u> published by *The News-Review* on Sep. 8, 2021. These maps are considered bi-partisan gerrymandered maps. According to the League, it would be better yet if an independent citizen commission draws up the maps. Voters should choose their politicians, not the other way around.



According to <u>People Not Politicians</u>, if the Legislature is unable to adopt legislative district maps by September 27, it becomes the duty of the Oregon Secretary of State to propose new state legislative districts to reflect shifts in Oregon's population over the last decade. If this responsibility falls to the Secretary of State, Secretary Fagan will create a <u>People's Commission of Oregonians</u> to advise her.

A place on the Secretary's commission would be a volunteer role with Oregon's Secretary of State's office. The Secretary is looking for Oregonians with diverse backgrounds and experiences to apply and will announce results by Sep. 27.

TACKLING THE PESTICIDES AND OTHER BIOCIDES CONSENSUS PROCESS

The term "biocides" might be new to you. It's a broad term for pesticides, herbicides, fungicides, rodenticides, and basically anything humans use to kill "pests."

In order to update and improve its ability to submit testimony on legislation related to biocide use, an LWVOR committee recently completed a two-year study called *Pesticides and Other Biocides*. Now, the LWVOR is asking members to read the study and provide input on biocide use and regulation and which organizations should be responsible for biocide-related policy.

This description of the study is from the LWVOR's website:

The use of pesticides is a balancing act between advantages and disadvantages. To understand the impacts, both beneficial and adverse, requires a broad overview of prevailing policy and the effects that policy has had. This study reviews the environmental and health costs and benefits of pesticide use, the current state of regulation at the federal, state and local level and the practices, and precautions presently in place for their use. It reviews potential improvements to regulations and changes to practices that could improve outcomes and protect the environment and human health while maintaining a stable, safe and reliable supply of foods and other farmed products.

Five key areas of pesticide development, use and policy were identified for review and potential improvements:

- 1. Education, training and labeling
- 2. Transparency and information gathering
- 3. Funding, research, and evaluation
- 4. Adaptive management and Integrated Pest Management
- 5. Burden of proof and the precautionary principle.

Our local League has scheduled our member consensus meeting for Tuesday, October 26 from 2:00-3:30 PM, by Zoom. We hope you will want to participate. You can read the study online or borrow a hardcopy from Robin Wisdom. After reading the study, prepare your personal responses to the Consensus Questions along with general comments. Have those handy when we engage in discussion and together, we will craft our local League input for submission to LWVOR.

The complete study comprises 52 pages plus eight pages of appendices. It includes a long list of references with e-links to a vast amount of information for the truly curious. If the Consensus Questions seem cumbersome, just try to distill your input into related comments. Don't worry! We'll work through this together.


Admittedly, this will require a bit of work, and may not be as much fun as some of your other pandemic pastimes, but LWVOR will appreciate your effort!

Announcing A Musical for the Ages!

Abigail Scott Duniway (1834-1915)

was a nationally known leader of the early woman's movement, a lecturer, organizer, writer and newspaper owner/editor of The New Northwest and devoted 40 years to women's rights. As a newspaper editor, Abigail wrote about social issues, such topics as voting rights, daycare, equal pay and equal protections.



Harvey Scott (1838-1910),

Abigail's younger brother, was a long-time Editor-in-Chief of *The Oregonian* at a time when Oregon women were working to gain suffrage. He was a dominant editorial voice in the Northwest for 40 years wherein he monitored politics and advised voters how to vote. Harvey's opinions differed greatly from Abigail's, and they frequently found themselves at opposite ends of an issue.

The League of Women Voters of Umpqua Valley is proud to announce a 42-minute musical, written and directed by Dr. Jason Heald, Umpqua Community College Professor of Music, featuring two actors and a pianist. The musical encompasses the history of advocacy pertaining to women gaining the right to vote particularly in Oregon, and then in other states.

As you may recall, we began working on this project with Dr. Jason Heald in 2020 as a way to celebrate 100 years of women's right to vote. Dr. Heald created the musical, directed and produced the project, and LWVUV sponsored the project. We also created an educational supplement for educators to accompany the musical. The long-term plan, post Covid19 restrictions, is to bring this project as a live performance to schools. Until then, a video of the performance has been created, along with educational material, that will be distributed to educators in our local schools, and possibly beyond.

We are currently working with our local ESD to distribute the musical and supplement to Douglas County educators. We hope to have this done by early October 2021.


