A Suffrage panel spoke prior to the

performance that day as well. Dori Jacob, Pat Sherman, and Alice Lackey told stories about several suffragists that had lived in Douglas County. It was so interesting! Dori spoke about Bethenia Owens-Adair, the first woman doctor to practice in Oregon. Pat told us about Kathryn Clarke, who was born in Douglas County and became the first woman to serve in the Oregon Senate. Alice brought us up to speed

on how many women have been elected to the U.S. government and how many women serve now. Oregon's legislature is composed of 44 percent women, and is number three among states for the highest proportion of women serving.



From the Supplemental educational material that was developed by League member Sherry Couron:

"This 35-minute musical, written and directed by Umpqua Community College Professor of Music Dr. Jason Heald, features two actors and a pianist. The musical encompasses history and advocacy pertaining to women gaining the right to vote. Abigail Scott Duniway was a women's rights advocate and newspaper owner/editor of The New Northwest. As a newspaper editor, Abigail wrote about such topics as voting rights, daycare, equal pay and equal protections. Her younger brother, Harvey Scott, was a long-time editorialist of *The Oregonian* at a time when Oregon women were working to gain suffrage. Harvey's opinions differed greatly from Abigail's, and they often found themselves at opposite ends of an issue. The musical has a connectedness to issues of the past with those of the present."

## The Quilted Beauty of the 19th Amendment Centennial



## The Quilted Beauty of the 19th Amendment Centennial

Back in October of 2019, our League was invited to be a sponsor of the 2020 Umpqua Valley Quilters' Guild's 37<sup>th</sup> Annual Quilt Show "Vintage Meets Modern", planned for April of 2020. In honor of the centennial celebration of the ratification of the nineteenth amendment, the show would include a set of art quilts in what was called the Women's Suffrage Quilt Challenge. We all know that April 2020 put a lot of plans on hold. For the quilting community, one of the side-effects of the COVID-19 pandemic was that a lot of quilters had more time to spend at their sewing machines! When the show was finally able to be held at the Douglas County Fairgrounds this April, the array of quilts on display was mind-bogglingly impressive!

The ten locally created Suffrage Quilts were all lovely and creative, some with a vintage feel and others more modern. It was a difficult choice, but we awarded the ribbon and \$50 prize to Myrt Thames. Her art quilt, on a gray and white fabric with vintage images, includes the yellow rose and sunflower (symbols of the pro-suffrage movement), along with a silhouette of a suffragist holding the purple, white and gold flag onto which Alice Paul sewed a new star each time a state ratified the nineteenth amendment. Thirty-six stars at last completed the flag with ratification on August 18, 1920.

The show at our fairgrounds also included a fabulous collection of Suffrage Quilts created by five central Oregon quilt guilds, and brought here by Susan Cobb, creator of two of the quilts. Purple for loyalty, white for purity and virtue, and gold for light, life, and Kansas sunflowers unified this collection. The artistry displayed in these 45"x45" quilts is truly amazing. I enjoyed meeting Susan, who also created a booklet with photographs and background information about each of these quilts. She left us extra copies. Maybe you can get one when you come to our Annual Meeting.

The Sisters, Oregon, community, known for their town-wide quilt show, held the 2020 Sisters Outdoor Quilt Show. Fortunately, they created videos capturing images of the many beautiful quilt collections.

Viewing the quilts is a chance to honor and celebrate the work of activists of the past and to enjoy the extraordinary talent of modern quilters.

## Vote411.org and lwvor.org/vote Voters' Guides



Vote 411.org is an ambitious undertaking by the League of Women Voters nationwide. Here in Oregon, League members have worked hard to provide voters with early and accurate information about what will appear on their ballots. In Douglas County alone, election clerks have to prepare about 200 different versions of ballots in one election since what's on your ballot depends on where you live and how you are registered. Many League members gather and submit information about candidates and measures to Vote411.org in a similar effort. Even though the League invites all candidates to participate in Vote411.org, some do not. Still, we hope it has been of some use to you and apologize for any inaccuracies.

#### It's An Election Year!

**The Primary Election 2022** is upon us. First of all, I hope you attended the Douglas County Commissioner Candidates forum on April 26th or watched it on our YouTube channel (<a href="https://bit.ly/3bfyx60">https://bit.ly/3bfyx60</a>).

**Vote!** Be sure to get your ballots in in time. The best way is to drop your ballot off at an Official Dropbox by May 17. You can find a list of Drop Boxes on the Douglas Elections webpage (<a href="https://douglascounty-oregon.us/178/Elections">https://douglascounty-oregon.us/178/Elections</a>). If you mail your ballot in, you don't need a stamp, but adding a stamp helps offset the expense for the state. And you must have your ballot postmarked by May 17. It will be counted even if it arrives late up to one week.



**House Bill 3291** requires ballots returned by mail showing the ballot was mailed not later than date of election and received by county clerk not later than seven days after date of election. The official certified results will be posted on the Douglas County Elections Department website and the Secretary of State's website on June 8 to June 13. <a href="https://douglascounty-oregon.us/178/Elections">https://douglascounty-oregon.us/178/Elections</a>.



## Board of Commissioners Candidate Forum, Held Live, April 26, 2022



Our League held a real, live, in-person forum after two years in the world of virtual reality. About 85 people, including League members, eight candidates, and members of the public, gathered in Cascade Hall at the fairgrounds on Tuesday evening, April 26. Among the candidates were the three sitting commissioners and five challengers. During the hour and a half long forum, we were able to hear opening and closing statements and responses to an array of questions from the public. Term limits, and why they don't apply to our commissioners, was a hot topic. Other topics ranged from preparing for climate change and drought, to how to sustain our branch libraries and improve the availability of childcare in our county. Every candidate wants Douglas County to remain in Oregon but will honor the vote of the people on that issue. It takes a lot to put on an event like this. We appreciate all who helped.

On a related note, the News-Review did not send a reporter, nor did they conduct interviews with the candidates and publish them, as has been their past practice. Apparently, they've been undergoing some staff changes, but if you wish they had provided more local election coverage, please let them know.

## **Living Room Conversations**



Perhaps you've heard about our new Communications Committee that started up this past year to talk about polarization and civil discourse in our community. In November 2021 we started thinking about and studying how to help bridge gaps and gain more understanding between Douglas County citizens. We found ourselves attracted to an organization, <a href="Living Room">Living Room</a> Conversations. Based on the recommended format, small groups of people get together to discuss what they think about certain subjects. The point is to listen to the other person with curiosity and with understanding. It is not to change people's minds. It's about *listening* to each other.

This spring has been so busy for your board of directors and committee members that we decided to wait until Fall 2022 to further develop this pilot project. After reconvening in the fall, it is our goal to engage 2 Republicans, 2 Democrats and 2 Independent/Unaffiliated Douglas County residents (for a total of six participants) to meet for 90 minutes once a week for four weeks who will participate in these conversations.
