The New LWV Membership System

LWVUS and ChapterSpot are still working out the kinks of the new membership system. You can log in, but we are still unable to make changes to the expiration. All of our members, except a few of those who have moved out of the area, paid their renewal dues that will not expire until 6/30/2026. Thank you so much for renewing your membership during the membership drive between October and December 2024.

There are no household settings now, therefore, each person must login separately to renew in the future.

How to login to the LWV Member Portal

Go to the portal: https://portal.lwv.org/

Enter your email address.

Click on the button "Continue with email".

You are emailed a 'Code' to your email address.

Check your email, you'll see the Code, then click on the button in your email that says, "Sign In to LWV Portal" and you will be entered into the LWV Portal.

You will be able to enter your personal information and access more in the Portal.

Log out when you are finished. In the top right corner of your screen, you'll see your name. Click there to see the drop-down box to log off.

Tell your Members of Congress to Oppose the SAVE Act

The House and Senate introduced the *Safeguard American Voter Eligibility* (*SAVE*) *Act*, which would require citizenship documentation to register to vote even though voters in every state are already required to affirm or verify their citizenship status when registering.

It is already illegal for noncitizens to register and vote in federal or state elections. The bill's requirement of a document to prove American citizenship to register to vote in federal elections is unnecessary and seeks to divide us. It also creates another barrier to voting.

Americans do not need MORE obstacles to vote. The *SAVE Act* would create one more barrier to the voting process, as many eligible voters do not have easy access to the necessary documents. Compared to white US citizens, citizens of color are three times more likely to lack documents such as birth certificates, passports, naturalization certificates, or certificates of citizenship or face difficulties accessing them. For example, while approximately half of all American adults possess a passport, two-thirds of Black Americans do not.

Tell your members of Congress to oppose the *SAVE Act*.

SFFC provides families facing crises with a compassionate and caring family-like community which we call a Circle of Support (COS). The COS provides resources, mentoring for youth and parents, overnight respite hosting of children 0-24 and respite childcare to support the family to regain stability. SFFC is professionally supported, and volunteer driven with a goal of keeping children safe and families together.

AGRICULTURE

The following Senate bills will be considered in the <u>Senate Committee On</u>

Natural Resources and <u>Wildfire</u> on March 6:

SB 78 – Replacement dwelling bill and <u>SB</u>

77 – home occupation reform bill.

SB 73 – Spot zoning reform; and SB 79 – prohibits certain dwellings on resource lands. LWVOR will watch and may support with our strong positions on protection of Oregon's valuable agricultural lands. Also, we are watching HB 3158 relating to photovoltaic solar power generation facilities on lands zoned for exclusive farm use. Allows certain photovoltaic solar power generation facilities on lands zoned for exclusive farm use to operate alongside farm or allowed nonfarm uses on a tract. LWVOR is watching this one before taking a position.

The League is watching HB 2947, a bill that would direct the Oregon State University Extension Service and the College of Agricultural Sciences of Oregon State University to study the distribution and occurrence of perfluoroalkyl and polyfluoroalkyl substances (PFAS) found in

biosolids applied to agricultural fields that do not produce crops intended for human consumption.

The Friends of Douglas County supports important land use bills. The following is borrowed from the Friends' latest newsletter, March 2025. Here's more on some of same bills mentioned above.

SB73 – Spot Zoning reform. Requires local governments to use the existing statutory planning process in ORS 215.788-794 to rezone designated agricultural and forest land for residential and industrial development. Stops the case-by-case rezoning of individual farm and forest properties to residential and industrial use.

SB77 – Home occupation reform. Closes the loophole that allows large hospitality and entertainment facilities being approved on land designated for agricultural and timber production. Restores the intent of Oregon's home occupation statute to allow homeowners to run small inconspicuous businesses, such as a small bookkeeping business, small hair salon, or small-scale childcare services, as accessory uses in homes located in farm and forest zones. Unlike the agri-tourism provisions in state law, home occupations are not required to be related to agriculture or to tourism. This bill makes the priority of the dwelling to be the home "residence" and not the home occupation as the priority use of the dwelling.

SB78 – Replacement dwelling reform. Stops the conversion of agricultural and forest land for luxury development through "replacement dwelling" process. Limits the scale of a replacement dwelling in ag and forest zones to be consistent with that of the dwelling being

replaced so that it is truly a replacement dwelling and not merely a new non-farm dwelling.

SB79 – Non-resource dwelling reform. Prohibits new houses that have nothing to do with agriculture or forest management from being built in critical groundwater areas, priority wildlife habitat and migration corridors, and on high value farmland.

Please show your support for these bills by letting members of the Senate Natural Resources and Wildfire Committee members who will be considering these bills that you support these reforms. It is okay to lump them together in a single letter to the committee members.

A hearing is expected to be convened soon on at least some of these bills in the Senate Committee. Please follow these bills and if you can, make some plans to testify either orally or in writing or both.



Special Districts Election Year 2025

What is a Special District:

Special Districts are a form of local government created to fill a specific community need. Communities have specific needs such as: Fire Protection, Education, Water, Sewer, etc. Communities have similar needs, but some have specific needs, so not every community has all of the same types of districts. Special districts are guided by various laws and statutes and have elected board members. More information regarding specific district types can be found under ORS 255.012.

Elected Boards:

Elections for Special Districts in Oregon are held every two years, in the odd years (2023, 2025, 2027 etc.) Generally, a term for a Special District board position is four years. If the individual elected to the term is unable to fill the whole term, the board may appoint another individual to fill the vacant seat until the next scheduled election. Please see ORS 198.320 (2) for specific wording. As one reviews the Districts and positions in the tabs to the left on the County Elections website,

one will see that there are some positions which state that the term is 2 years. These are due to a vacancy that occurred.

Districts that file with our county, there are another 16 Special Districts which we share with other counties. The shared districts originate in 2 different counties: Coos, Lane. If an elector lived in one of these districts and wished to file for candidacy in one of the shared districts they would file their candidacy with the county of origin. There will be many positions open for filing, from February 8th until March 20th @ 5:00pm. Voters will only see those districts and positions on their ballot in which they are eligible to vote (in the area of residence.)

What is that district? Who is that?

Many people do not know how many

Douglas County currently has 83 Special

Many people do not know how many different districts they are in, or who the candidates are. The question often comes up during the Special District Election "Who are these people?". These "people" are your neighbors; people in the community that are *giving* of their time to assist a board perform its duties. These are non-paid positions. Typically, the candidates are not going to pay out for signage, television, or other advertising. However, you may contact them. Filing forms are hyperlinked to the names of the filed candidates. You may also contact the districts.

Time to Give

If you want to be involved in your community this is a great way to help out. Depending on

the district this is often one meeting a month. If you are able to donate more time for your community, you can sit on more than one board as they are not paid positions. Thank you to all that are able and do donate their time to make our communities function.
