### OF OUR LAWS AND OUR MORALS

In the debates over the current administration's actions aimed at removing people who have entered our country illegally, those who support those actions make their case on the grounds of legality. But when anti ICE protestors are shouting "Shame!" they are making a moral statement. This makes it difficult for any meaningful discourse because laws and morals are not the same thing. Instead, these are two distinctly different ways for societies to deal with social ills.

One key difference is that morals are simple to understand while laws are often complicated hard knots to untangle. The Golden Rule is a single sentence. The statutes, codes, ordinances and regulations of the federal government, state governments and municipalities that we live under require entire libraries like the one in our county courthouse. HR 1, the One Big Beautiful Bill passed by congress last summer is estimated to have run to somewhere between 870 to 1,000 pages—about as many pages as my copy of the King James Bible.

When the protestors watch videos of the ICE and Border Patrol agents in action and apply the Golden Rule by asking “Is that how I would want to be treated?” The answer comes easily. It doesn’t require a lawyer’s argument or a judge’s ruling to instinctively recoil from scenes of violence. Whether any particular violent act is from law enforcement or from protestors may be debatable, but seeing violence is always shocking and distasteful to anyone with the ability to have empathy for a fellow human.

To rely on laws as a substitute for morals and ethics in your personal life or business dealings would be a narrow-minded and foolish way to live, a good way to risk alienating your family, friends, and neighbors and your customers as well. As Mr. Bumble put it in Oliver Twist “...the law is a ass—a idiot.” It is an awkward and clumsy system, one requiring the human wisdom of judges and the reasoned consensus of juries.

At their best, our laws serve to protect us from harm; at their worst they can bring us harm. American History contains many unjust and often cruel laws. The U.S. Supreme Court’s 1857 ruling in Dred Scott v. Sanford and the 1896 case of Plessy v. Ferguson are both considered unconscionable nowadays but stood in their times as the law of the land. The 1935 racist and antisemitic Nuremberg Laws of Nazi Germany were based, in large part, on America’s Jim Crow Laws, both of which were strictly legal then but were never morally defensible.

There is a saying about the laws which tells us that “There are times when we must do more than what the law requires and times when we must do less than what it allows.” The laws can provide us with guidance, but morals, ethics and common sense must be applied when using them if the goal is to have true justice.

Sociologists call the moral codes of societies the mores. These are generally unspoken rules of behavior which are followed by the overwhelming majority of people. They act as the glue that hold cultures together, keeping us from destroying our society. They are actually more important to promoting “the good of all” than are our laws. As the French philosopher Emile Durkheim put it, “When mores are sufficient, laws are unnecessary; when mores are insufficient, laws are unenforceable.”

The so-called “culture wars” of the twenty-first century are, at heart, differences of moral stances based on differing interpretations, one based on the fear of potential new injustices coming along due to changing societal standards and the other seeking to correct old injustices by adopting changes in how we treat each other. It is sad that we live in such a worrisome time, and sadder still that it is one made worse by those who exploit our fears by fostering distrust.

Observers are only present at meetings; they do not participate or even say anything. We only ask that you take notes and then report to the League board. ***We need You!***




If you would like to spend a few hours a week or monthly, this is for You. You can help your League **and** community by signing up to be present at local government meetings and being consistent.

## **Key Postmark Rule Change (Effective Dec. 24, 2025) *Merry Christmas! (#@%!\*&^!)***

**The new postmark rule may interfere with the mailing and receipt of your ballot beginning this year. We need to let everyone know!**

Even if you mail your ballot early, it still may not make it on time to be counted. Starting April 1, 2025, mail from many post offices (over 50 miles from processing centers) sits overnight, adding a day to delivery and postmark dates.

Add a further delay: Postmarks now show when mail is first processed by a machine, not when you drop it off. This can make mail appear late for deadlines (IRS, ballots, legal docs).

### **Best Ways to Get Your Ballot into the Elections Office ~**

- **Go to a Post Office** and request a free, manual postmark for the actual mailing date.
- **Use a Drop Box** – There's a Drop Box in the Courthouse near Room 124, outside the Courthouse, and in the Roseburg Public Library. Other Drop Box locations: <https://www.douglascountyor.gov/179/Official-Drop-Site-Locations>.

## Winchester Dam in the News

As of 12/22/25, a new court ruling says the dam owners must build an official fish ladder on the dam by 2028. A new fish ladder could cost \$70 million.

Some interesting facts about the Dam leading up to this new decision ~

The North Umpqua River is a tributary of the Umpqua River that is inhabited, and historically has been inhabited, by native migratory fish species, including winter steelhead, summer steelhead, fall chinook, spring chinook, coho salmon, cutthroat trout, chum salmon, pink salmon, sockeye salmon, pacific lamprey, Umpqua pikeminnow, tyee sucker, and sturgeon.

Winchester Dam (the Dam) spans the North Umpqua River in Douglas County, Oregon, approximately five miles north of Roseburg, Oregon, and approximately 118 river miles from the Pacific Ocean, to which the waters of the North Umpqua River and Umpqua River ultimately flow.

The Dam was originally constructed in approximately the late nineteenth century and reconstructed in approximately 1905. The Dam was originally constructed as a log crib dam, in which a lattice of horizontal and vertical logs was filled in on the upstream side with natural materials such as rocks, gravel,



and sand, with the bulk of the Dam's volume composed of natural infill material.

And there is much more history on record. You can read it all [here](#) in the Proposed Order. But getting down to the ruling, it was stated that the "Respondent [the dam owners] bore the burden of proving, more likely than not, any facts necessary to support the affirmative defenses it has proposed. The Department met its burden; Respondent did not."

The Conclusions of Law (page 34 of the Proposed Order) stated that the Respondent

executed "construction" on Winchester Dam during the repairs it completed in August and September of 2023, "thereby triggering the fish passage review process set forth in Oregon law and rule, and that it may therefore

require that Respondent install Department-approved fish passage at the Dam."

The Winchester Water Control District may file "exceptions" with the ruling, but it must be in writing and happen in 14 days after the Proposed Order was served (12/18/25). After that and other possible actions, the Oregon Fish and Wildlife Commission will issue a Final Order.
